#### Safety Equipment:

- First Aid Supplies: inside the Erg Room Plaza Door (to the left); in each launch Safety Box
- Automatic External Defibrillator (AED): inside the Erg Room Plaza Door (to the left)
- **Fire Extinguishers**: Four (4) inside the Erg Room, Two in the BH (Exit Doors); One (1) by the Flammable Locker, One in every launch Safety Box.

#### Launches must carry at all times:

- Life Jacket (Kippy) Bag with at least 16 PFDs, throw PFD (cushion), Pump, and Throw Line
- VHF Radio and Optional Cell Phone
- Safety Box (sound making device(s), fire extinguisher, first aid kit, space blankets, tools, EAP)
- Paddle, bailer, PFDs worn by all occupants

#### Independent Rowers should carry at all times:


- Cell Phone with key numbers favorited (Harbor Patrol 202-727-4582, Coaches)
- Whistle or other sound signaling device
- Bow and Stern Lights plus Head Lamp in low-light conditions


#### In the event of a capsize:

- If possible, reenter the boat and return to the boathouse
- Or, stay with the boat to use as a flotation device and swim towards the nearest shore
- Pair up with other rowers and stay in constant communication until rescued
- If assisting, stabilize capsized boat to help rower(s) reenter boat; call help if needed.
- Contact coaches if unable to return boat to the boathouse

#### **Medical Emergency on the Water:**

- Raise the alarm; have someone call Harbor Patrol 202-727-4582/VHF-16; assist the victim
- Harbor Patrol will likely respond directly to your location. When speaking to Harbor Patrol, provide location based on established physical landmarks.
- If directed by Harbor Patrol, take the victim to an Emergency Egress Location
